



GOLF CART POLICY

1. Golf cart driver must either (1) have a valid driver's license; or (2) be driving with an adult with a valid driver's license.
2. Registration with CCMC is required, by filing with the CCMC office the **Application to Operate a Golf Cart on the Streets of Cannonsgate at Bogue Sound**, stating that the homeowner has read the Golf Cart Policy and agrees to abide by the Policy and assumes responsibility and liability for the operation of the golf cart.
3. After proper registration with CCMC, the homeowner will receive a sticker that is to be placed in a visible location on the lower corner of the windshield on the driver's side.
4. Posted speed limits must be observed throughout Cannonsgate at Bogue Sound.
5. Golf carts operated after sunset must have lights turned on.
6. Golf carts may not be operated during quiet hours (12AM – 5AM).
7. Golf carts must be operated properly and safely; to be driven on roadways and cart paths only.
8. Maximum seating capacity of the golf cart may not be exceeded.
9. Homeowners are responsible for any damage to personal property or injury to individuals that result from accidents involving their golf cart.
10. Any violation of this Policy shall result in the following:
 - a. First violation shall result in courtesy letter issued from CCMC.
 - b. Second violation shall result in a warning letter issued from CCMC.
 - c. Third violation and after, the homeowner could be subject to potential fines and/or suspensions pursuant to the Declarations.
